William L. Lassiter, Deputy Secretary for Juvenile Justice

- Review of actions taken by Juvenile Justice in response to the COVID-19 pandemic.
- Reminder of Raise the Age budget allocation.
- Comparison of Raise the Age projections and actual impact. Note that the pandemic has also had an impact on numbers. Further discussion on distribution of complaints received across the state and offense types.
- Review of detention capacity, population, and average length of stay.
- Update on H593 implementation.
- Update on planned YASI implementation.

### Legislative Revisions and Legal Issues Subcommittee

Heather Taraska, Chair, and Jacqui Greene, UNC School of Government

- Presentation of proposed revisions to G.S. 7B-1601 (technical correction of jurisdiction of delinquent juveniles) and G.S. 7B-1602 (extended commitments).
- Presentation of proposed revisions to G.S. 7B-2514 (technical correction of post-release supervision) and G.S. 7B-2600 (language to separate delinquent and undisciplined youth for authorities to modify or vacate).
- Discussion about transfer/remand and secure custody orders. Further discussion about the role of clerks in obtaining secure custody orders.

- Discussion about changes to G.S. 7A-271, G.S. 7B-1902, and G.S. 7B-1906, in addition to G.S. 7B-2204.
- Motion to accept changes. Roll call vote. Motion passed.

### Minimum Age Subcommittee

Judge J. Corpening, Chair

- Review of committee meetings and research topics.
- Subcommittee voted to raise the minimum age of juvenile jurisdiction to 10.
- Request received to present changes to the Executive Committee of the Conference of the District Attorneys and the Sheriff's Association prior a vote by JJAC. Vote so held.
