### **Roadmap to RtA System Implementation**



- Use of evidence-based system reforms that are tried and true<sup>1</sup>
  - Expanding use of diversion
  - Making probation and aftercare approaches more effective
  - Addressing MH needs
  - Reduce use of pretrial detention
  - Reduce reliance on secure facilities, focusing on community-based approaches
  - Keep youth safe via PREA(Prison Rape Elimination Act) compliance
  - Improve JJ's management of resources, serve youth more effectively

# JCPC RtA Expansion Strategies- Readiness from the Get- Go!

#### JCPC Tiered Planning

- Executed continuum building plans in preparation of RtA expansion funding- JCPCs advance planning to execute local Program Agreements once budget allowed
- Executed administrative directive requiring access to restorative justice model programs in all counties
  - Benefits of diversion/restorative justice programming<sup>2</sup>
    - Reduces trauma associated with JJ involvement and helps build health relational and community support-gives opportunity to take responsibility
    - Rehabilitative rather than punitive leading to reduced recidivism
    - Cost savings vs use of JJ system
- Establish multi-county/regional-based programming options(HB 593)
  - Edited general statute to allow multi-county and multi-district programming options
  - Greater flexibility given to provide intensive services based on needs not disposition levels
  - Enhanced NCALLIES functionality to support multi-county/district programming
    - Ex: Kids at Work, vocational program with 17 -county access



**§ 143B-853. Funding for programs. SECTION 6.(b)** The funds described in subsection (a) of this section shall be known as funds for intensive intervention services and shall be used for the purpose of providing intensive intervention services for juveniles of any disposition level, based on the needs of the juvenile, as ordered pursuant to G.S. 7B-2506. Intensive intervention services are evidence-based or researchsupported community-based or residential services that are necessary for a juvenile in order to (i) prevent the juvenile's commitment to a youth development center or detention facility or (ii) facilitate the juvenile's successful return to the community following commitment.

H593-Recodification of G.S. 143-B-1104 to define "Intensive Services"



#### Intensive Intervention Services

#### JCPC

- County Specific
- Address needs of youth identified in a specific county

JCPC-Endorsed/ Alternative to Commitment

- Regional Services
- Address more enhanced needs of youth with targeted services in specified counties/ Districts (Multi-County Program Agreements)

**Statewide Contracted Services** 

- Available to youth from all 100 counties
- Address youth who have more complex needs
- May be residential or communitybased

### **Teen Traffic Court Pilot**

- Initiative with the 13th District
- Piloting diversion of specific
  Chapter 20 offenses to Traffic Teen
  Court model
  - Identified 25 specific Chapter 20 offenses
  - Examples: No operator's license, No insurance, Reckless driving, speeding
- Uses "Alive at 25" Curriculum completion for consideration of deferred prosecution

### Alive at 25 Course Content (Virtual and Role Playing)

- Youth better understand why young adults often underestimate risk
- Understanding the consequences of making poor choices and taking unnecessary risks
- The negative effects and dangers associated with distractions, peer pressure, and driver inexperience
- Current state laws regarding speeding, impaired driving, seatbelt usage, and cell phone and texting use
- Understanding of how a young driver can take control of situations to help achieve a desirable outcome
- Collision prevention techniques and defensive driving strategies
- Responsibility of passengers and how to properly manage peer pressure





### Teen Traffic Court : *THE POWER OF A GOOD IDEA!*

- Juvenile Crime Prevention Council (JCPC) Policy states that a "<u>JUVENILE COURT COUNSELOR</u>" shall not refer a case to a teen court program if the juvenile is alleged to have committed any driving while impaired under G.S. 20-138.1, 20-138.2, 20-138.3, 20-138.5, or 20-138.7, "<u>OR ANY OTHER MOTOR VEHICLE VIOLATION</u>"
- Does not prevent the District Attorney, Judge or District Court from referring a motor vehicle violation case to Teen Court.
- Collaborations between DA, Program Managers in the 3 county Judicial District developed the idea of Teen Traffic Court
  - Pending change of language in the JCPC policy that will allow a District Attorney, Judge or District Court to refer motor vehicle cases to a specialized Teen Court.

### **RtA State Contract Expansion Strategies**

- Residential Programming Expansion
  - RtA data supported a projected need of 66 Beds
- Expansion of Community-based FFT Contract
  - Access in 100 counties



- Expansion of Crisis and Assessment Center for eastern area access
- Telepresence enhancements at all residential sites

### Who is Community Programs Serving?



 Of youth 11 and younger in programs:

- 15% were identified as Exceptional Children
- 7% had a history of short-term suspensions
- 2% had a history of running away
- 1% were attending an alternative school
- Represent 13% of the total which is 1,599
