RE: Governor's Crime Commission Grants to State Agencies Report

DATE: February 17, 2020

Pursuant to N.C.G.S. 143B-602(7), prior to any notification of proposed grant awards to State agencies for use in pursuing the objectives of the Governor's Crime Commission outlined in this section, the Secretary shall report to the Senate and House of Representatives Appropriations Committees for review of the proposed grant awards.

Compiled below is a list of all state agencies that have applied for funding through the Governor's Crime Commission. These grants have not yet been reviewed by Committees or voted on by the full Commission. If applications submitted by these state agencies are approved, funding will be available when the new federal fiscal year opens, October 1, 2020.

Fields & Definitions.
