Greene Correctional Institution is a minimum-security prison located in Maury, North Carolina. It has the capacity to incarcerate 616 adult males and has a segregation unit that can hold 40 inmates for a total capacity of 656. This is the facility's second PREA audit. The current audit was obtained and assigned to the Auditor, Robert Manville, through TrueCore Behavioral Solutions, LLC located in Tampa, Florida.

There were no barriers in completing any phase of the audit. The Auditor had unfettered access to the facility and all encountered staff members were receptive to the site visit and responsive to the Auditor.

PRE-ONSITE AUDIT PHASE

Prior to the site visit, the flash drive with uploaded information was provided to the Auditor for review. The PREA Compliance was contacted by the Auditor to review the PREA Pre-Audit Questionnaire (PAQ); and to discuss if there had been any new findings that had occurred since the PAQ had been completed.

The facility staff shared many correspondences with the Auditor prior to the site visit which included, but was not limited to: administrative reports, contracts, incident reports, memorandums, policies, brochures, staff rosters, PREA audit notices, staffing plans, training information, and other reference materials for examination prior to the on-site visit.

The facility was very responsive to providing further clarification when needed; and within the appropriate timelines given, both prior to and during the site visit.

ONSITE AUDIT PHASE

On the first day of the onsite audit, an entrance meeting was held at the facility to discuss any concerns regarding the audit process and to finalize the facility site review and interview schedules. The following persons were in attendance: PREA Compliance Manager; Assistant Compliance Manager; and the Acting Superintendent.

After the briefing with staff, a site review was conducted. The tour included the intake processing areas, all housing units, recreation areas, facility support areas, vocational area, health service area, food service area, and the visiting rooms. Persons of the opposite gender announced themselves each time they entered a housing unit or dormitory.

Signs were posted (in English and Spanish) informing the inmates that "employees of the opposite gender were present in the housing units". Based on the observation of the showers on the unit and interviews with the inmates, inmates are able to shower, dress and use the toilet facilities without exposing themselves to employees of the opposite gender.

Informal and formal conversations with employees and inmates regarding the PREA standards were conducted. Posters specific to PREA violation reporting and the agency's zero-tolerance policy for sexual abuse and sexual harassment were prominently displayed in all housing units, meeting areas and throughout the facility.

During the comprehensive site review, posters were observed providing instructions on how inmates could confidentially contact Forgiven Ministries to report sexual abuse or sexual harassment. Audit notice postings with the PREA Auditors' contact information were also located in the same areas. Staff provided a memorandum indicating the date the audit notice was posted. The Auditor did not receive any confidential letters from inmates or staff as a result of the audit notice postings. The inmate phone system was tested for serviceability for reporting allegations to outside sources.

Following the site review of the facility, interviews were conducted with specialized staff. The interviewed included the PREA compliance manager, Acting Superintendent, Assistant Superintendent for Programs, two (2) clinical psychologists, two (2) investigators, two (2) staff assigned as PREA Support persons,

Nursing Supervisor, Chaplain that serves as volunteer coordinator, Officers In Charge (OIC) for first and second shift. A facility staff roster was provided by the PREA Compliance Manager and the Auditor randomly chose available staff from the roster to be interviewed. During the first day the Auditor interviewed five (5) correctional staff and one (1) volunteer.

Also the Auditor reviewed ten (10) personal staff files, fifteen (15) inmate records, fifteen (15) employee training records, fifteen (15) computerized screening instruments, three (3) investigator files, and three review team records. The investigative files contained forms provided to inmates on retaliation and notification of inmate which were also reviewed. The investigator responsible for the investigations was interviewed to discuss files and how conclusions were determined.

On day two of the onsite audit, all living units were revisited and general conversations with staff and inmates were engaged during the visit. During the tours, staff was observed to be interacting with inmates in a positive and helpful manner. Following the tour, interviews were conducted with staff and inmates. A total of sixteen (16) correctional staff and thirty four (34) randomly selected inmates were interviewed. One (1) inmate had identified as transgender. The facility psychologist had initiated protocol for NCDPS Transgender review panel to institute determination of appropriate gender specific identification. The inmate indicated he did not consider himself transgender and had decided to request the psychologist to withdraw protocol. Three (3) inmates identified by mental health staff as having cognitive deficiencies. Two (2) inmates had physical disabilities including wheel chair bound and critical medical conditions.

A review of the investigative files alleging sexual abuse or sexual harassment was conducted for the twelve months period prior to the audit. There was a total of six (6) allegations of sexual abuse or sexual harassment filed by inmates. All six (6) incidents were investigated. Of the six (6) allegations, one (1) was a grievance alleging sexual harassment that was resolved within 90 days. One (1) was reported by another facility upon receiving inmate that was transferred from Greene Correctional Center. Three of the cases were referred to an outside law enforcement agency for investigation. Criminal investigations are conducted through an agreement with Greene County Sheriff's Office. These investigations were still being investigated. Three allegations were determined to be unsubstantiated. None of the cases required forensic evidence collection by a SANE service provider in the community. The PREA Compliance Manager is in weekly conversation with Greene County Sheriff Investigators.

The audit notices were observed posted in various areas of the facility and according to staff had been posted since April 4, 2018 however no pictures were sent to the Auditor. This issue has been dealt with in a corrective action with the facility leaving the notice posted for an additional time period. The corrective action is further discussed in the report. The notices contained the contact information for the Auditor. No type of correspondence was received by the Auditor from residents or staff regarding PREA related issues or any other contact made.

POST ONSITE PHASE

Following the onsite audit phase, contact was made with the facility to determine if they had named a new Superintendent, to which they had not. Additionally, contact was made with the facility to follow up on the progress in addressing their retaliation monitoring practice with all staff to ensure it is initially conducted for a full 90-day period. One inmate retaliation was terminated for less than ninety (90) days. The facility shared their plans to continue re-training additional staff. In the interim until completion, the

facility shared they had mounted posters throughout the facility, describing the correct retaliation monitoring practice until all staff in the facility are re-trained.

Facility Characteristics

Greene Correctional Center has 7 living units, with a total of 12 dormitories. Two units are designed with a central control and four open dormitories. Each of the dormitories have a shower and bathroom area in the back of the dormitories which provides an area for inmates to shower and change clothing. There are three officers assigned to each of these units. The third unit is a large dormitory with four (4) rows of bunk beds. There is a bathroom and shower area located in the back of this dormitory which provides areas to shower and change clothing without being seen by persons of the opposite sex. There are two correctional officers assigned to this living unit.

The facility has three units with the same type of configuration. The unit doors are electronically locked. The units also include office areas for case managers and correctional officers. Additionally, these units have a central area with a dormitory on each side of the control room. The dormitories have a shower, bathrooms, and changing areas that allow inmates to dress, shower, and use the restrooms without being in view of person of the opposite gender.

These units have a central control operator and two correctional officers assigned to each unit.

The facility segregation unit has 40 beds that are divided into mental health treatment programs, administrative and protective custody cells. There is a shower area within the segregation unit that allows inmates to shower and dress without being viewed by persons of the opposite gender. There are three correctional officers assigned to the segregation unit.

There is a Multi-Purpose room located in the perimeter area. This area is used for vocational, educational, kitchen/dining and other offices. This area is manned by a Correctional Officer in kitchen/dinning and educational programs whenever inmates are located in these areas.

Located in this same area is a stand-alone building that houses the mental health staff. This area includes private offices and group rooms for mental health staff. This area is manned by a Correctional Officer whenever inmates are located in this area.

Outside recreation includes a large outdoor recreation area with basketball courts and a weight area.

The facility has a Medical building which houses medical examination rooms, offices and observations rooms. This area is manned by a Correctional Officers 24 hours per day. There is one officer assigned to the entrance area and other officers assigned to provide supervisions for the observations and examination rooms.

The administrative and support staff are located outside the perimeter of the secure area. The facility superintendent and assistant superintendent offices are located in this area.

Inmates can work jobs within the institution performing supportive roles in food services, custodial maintenance, landscaping, and general facility maintenance. Additionally, some inmates may be selected to work jobs within surrounding government agencies, while other may be granted work release. Work release allows an inmate to report to a job in the private sector during the day and return to the prison at the end of their shift, preparing the inmate for life after release.

While the facility continues to provide work details and limited work release programs, the facility has transitioned to housing more medical and mentally disabled inmates. The segregation unit is reserved for offenders with safety/security concerns or for those who become difficult to manage.

PREA information was observed in each area of the facility that inmates and staff have access. This information included PREA Zero Tolerance; Forgiven Ministries' phone number and how to contact this organization privately without providing a pin number; information regarding Rape Crisis Center; and the North Carolina Department of Public Safety hotline, website, phone number and PREA Auditor's Onsite Notice. All PREA Information was in Spanish and English.

Summary of Corrective Action (if any)

The facility has documentation indicating the posted information required for the site visit was done on April 4, 2018. The facility did not provide pictures or any other proof that the information was posted on April 4, 2018. An interview with the PREA Compliance Manager confirmed the date that the information was posted. Interviews with staff and inmates indicated the information had been on the bulletin boards for several months. The Auditor asked the Compliance Manager to keep information on the board and to advise or ensure Auditor's receipt if there were any staff or inmates correspondences during the next month. Based on the information provided and interviews with staff and inmates there are no other recommendations at this time.

Standard 115.72: Agency Protection Against Retaliation: A review of the retaliation found that all inmates making allegations were assigned a PREA Support Personnel (PSP). There was one case where an inmate was under retaliation monitoring after making an allegation. This retaliation monitoring was discontinued after his allegation was found to be unsubstantiated which was prior to the end of the 90-day period. The PSP staff has been re-trained regarding the process by which retaliation monitoring is to start and end.

The North Carolina Department of Public Safety provides supervision of the prisons. The agency has several policies that mandate the staff, visitors, volunteers, contractor, inmates and all other persons that have any access to inmates, must adhere to the zero tolerance of sexual abuse and sexual harassment policy.

North Carolina Policy Prison Chapter A .002 Conduct of Employees, establishes the agency's legal authority to establish actions that are considered in response to a felony for employee and contractor working for or on behalf of the agency. Similarly, the North Carolina Department of Public Safety Policy, Inmate Sexual Abuse and Sexual Harassment, Chapter F Section .3400 provides guidelines for the prevention, detection, response, investigations, prosecution, and tracking of inmate on inmate and staff on inmate sexual abuse and harassment.

This policy also mandates the agency's zero-tolerance of sexual abuse or sexual harassment. The agency employs a full time PREA Director that reports to the General Counsel for North Carolina Department of Public Safety. There are 140 PREA Compliance Managers assigned to NCDPS. This information was verified through organizational charts provided by the agency and through documented interviews with the PREA Director, facility Superintendent, facility PREA Compliance Manager and PREA Assistant Compliance Manager at Greene Correctional Center.

Based on the interview with the PREA Director, she has sufficient time, resources and management support to manage the agency's PREA mandates. This was also verified through interviews with the facility Acting Superintendent, and the PREA Compliance Manager who indicated the willingness and support they received for the agency- wide PREA Director.

Greene Correctional Center has a PREA Compliance Manager, Assistant Compliance Manager and three staff that have been assigned collateral duties to serve as PREA Support Persons. Greene Correctional Center has developed and implemented Standard Operation Procedure (SOP) 8.7 Sexual Abuse and Sexual Harassment. The facility provided a memo establishing authority for the PREA Compliance Managers and Assistant PREA Compliance Manager to serve in these positions. This Memo was addressed to all staff and copied to the Regional. Interviews with the PREA Compliance Manager and his team verifies he had the time, management support and staff resources required to coordinate the facilities efforts to comply with PREA Standards.

The policy provides that the facility's staffing plan takes into consideration the composition of the inmate population in calculating adequate staffing levels and determining the need for video monitoring.

The facility's staffing plan takes into consideration the programs occurring on a shift in calculating adequate staffing levels; and determining the need for video monitoring. The facility provided a staffing analysis for 2018 which included all areas of the policy requirements.

There have been no findings of inadequacy relevant to this standard.

All essential posts are filled on each shift and no essential posts are kept open. When programs are offered, staffing is increased to provide additional supervision. The

review of the facility's PREA rounds logs confirmed intermediate-level or higher-level supervisors, including shift supervisors, (and department heads at a minimum) conduct and document such visits throughout the facility to include nights and weekends. When programs are offered, staffing is increased to provide additional supervision. Greene Correctional Center provided a list of incidents by date, time, location, and type of incident.

NCDPS Prison Policy F .1600 Management of Security Post requires that facility heads and facility assistants conduct unannounced rounds on each shift. It also prohibits staff from alerting other staff members that these rounds are occurring unless such announcement is related to the legitimate operational function of the facility.

Greene Correctional Center's Supervisor Post Orders require that supervisors complete an inspection of all areas of the facility and document checks on a regular basis. A review of the log books, interviews with staff and supervisor provided documentation that the Shift Supervisor, Assistant Director and facility's Acting Superintendent makes unannounced rounds in the living units on a routine basis including nights and weekends. Greene Correctional Center provided a daily log which includes PREA daily unannounced rounds of all living units.

North Carolina Department of Public Safety Prison Policy .0100 Operational Searches and Greene Correctional Center SOP 8.9 Searches establishes the governance of searches at the facility. The facility policy requires males will pat search only males and female staff may pat search males or females.

Gender specific staff will conduct all strip searches except for exigent circumstances. These exigent circumstances must be documented; and the search must be approved by the OIC. Any strip search conducted by a non-gender specific staff will be forwarded to the Department's OPUS Incident reporting system and will be forwarded for investigation.

There have been no strip searches conducted by non-gender specific staff at Greene during the last several years. The facility does not house female inmates.

The showers are partitioned. The partition allows for staff to observe the head and feet levels of each inmate while block view of the mid-section. All staff members are trained on gender specific guidelines. This training includes that all inmates can shower, perform bodily functions, and change clothing without staff of the opposite gender viewing their buttocks or genitalia, except in exigent circumstances or when such viewing is incidental to routine cell checks.

Greene (SOP) 8.17 Sexual Abuse and Sexual Harassment mandates this requirement as well as the policy to address requirement that staff of the opposite gender announce their presence when entering an inmate housing unit. There are posters located in the day room, officers' stations and other areas throughout the facility that state staff must announce their presence in entering an area of the facility that houses the gender different from the staff member.

The staff members are trained upon hire; as well as annually, on the mandate that all staff of the opposite gender must announce their presence when entering a housing unit. The North Carolina Department of Public Safety has posters in all the officers' stations; and on bulletin boards, that specific address requirements for cross gender viewing and searches by facilities.

Prior to taking over, the oncoming shift announce a female is working the building. The female staff announces their presence again when they enter the living area.

Verification of the requirements was documented in the training logs, during interviews with staff and inmates and during tours throughout the facility. Facility Policy F.1600 mandates that the staff will receive training; and comply with the policy in that, the staff will not search or physically examine a transgender or intersex inmate for the sole purpose of determining the inmate's genital status.

Interviews with inmates confirmed that they had been pat-searched by officers properly and professionally. Staff training records, and staff interviews verified that they had received training which includes who may be searched and the professional manner to complete searches.

Interviews with staff/inmates, personal observations and an examination of policy and supporting documentation confirm compliance with this standard.

NCDPS Prison Policy F.3400 as well as Greene Correctional Center training curriculum address implementation of Agency Mandates. All PREA related information, including postings, brochures and handouts, are available in English and Spanish languages. Staff also may read information to inmates when necessary. Translation services are available through a contracted language service for inmates who are not English proficient for any language.

Communication services are available for inmates who use sign language. The facility does not rely on inmate interpreters, inmate readers or other types of inmate assistants in the performance of first responder duties or during the investigation of an inmate's allegations. Interviews with first responders, medical, mental health and investigative staff confirmed their awareness of the prohibition of using inmate interpreters for PREA compliance functions. The agency provided several documents that validate policy for all areas of this standard. These include New Hiring Prohibitions, Promotion Prohibitions, New Employee Hiring Policy, Hiring Process Manual, External Web Employee with DPS and several memos forwarded to the facility staff. Each of these documents require pre-employment background checks, another background check within five (5) years of initial employment; and a background check for all promotions prior to being offered a promotion.

Fifteen (15) personnel files were examined by the Auditor to ensure compliance with all aspects of this standard. All employees who have contact with inmates have had a background check.

Contractors and volunteers who have regular contact with inmates also have criminal backgroundchecks completed prior to having contact with inmates. Volunteer and contractor background checks are repeated yearly. A review of the visitors file provided update background checks. The facility does not hire or promote anyone who may have contact with inmates, and does not enlist the services of any contractor who may have contact with inmates who has engaged in any type of sexual abuse or sexual harassment (no exceptions). Employees have a duty to disclose such misconduct and material omissions regarding such misconduct may be grounds for termination. Failure to do so is grounds for the applicant's hiring process to be terminated.

The Human Resource Manager (administrative officer) was interviewed and confirmed that the agency contacts prior employers for information on substantiated allegations of sexual abuse or resignations which occurred during a pending investigation of sexual abuse. The Human Resource Manager (administrative officer) also confirmed the agency provides information on substantiated allegations of sexual abuse or sexual harassment involving a former employee, upon receiving a request from an institutional employer for whom such employee has applied to work. The policy provides that the facility notifies appropriate licensing/certifying agencies when professional staff members are terminated for substantiated allegations of sexual abuse or sexual harassment.

NCDPS Prison Policy F.3400 Inmate Sexual Abuse and Sexual Harassment establishes the requirements for first responders, investigators and medical staff to secure the crime scene including the areas of the offense, the victim, and alleged abuser for the preservation of usable evidence. The policy mandates that persons responsible for investigating allegations of sexual abuse follow a uniform evidence protocol that maximizes the potential for obtaining usable physical evidence for administrative proceedings and criminal prosecution.

Investigators are trained and follow appropriate curriculum for a uniform evidence protocol that maximizes the potential for obtaining usable physical evidence for administrative proceedings and criminal prosecution. North Carolina Public Safety Prison Health Services Policy and Procedure Manual Policy CP-18 references that this policy and procedure is based on Department of Justice "National Protocol for Sexual Assault Medical Forensic Examination, Adults / Adolescents.

The facility has developed and trained staff on a Coordinated Response Plan. The facility also has trained all PREA Support person roles and responsibilities to assist in coordinated responses of sexual abuse. The facility uses the services at Vidant Medical Hospital that maintains a Sexual Assault Nurse Examiner at all times. The facility also has a Memorandum of Understanding (MOU) with the Rape Crisis

Center. Based on the MOU and interview with the Crisis Center representative, the Center provides a person to accompany the victim during the forensic examination. Further, the Crisis Center has a working relationship with Vidant Hospital to also assist victims during the investigation process.

The Rape Crisis Center also provides emotional support, crisis intervention, information, and referrals. The facility has a full-time Licensed Psychologist that also provides support. Based on interviews with Rape Crisis Center Director, all staff members providing services for the Crisis Center have educational and training qualifications in order to provide the services as indicated in the MOU which mandates that Rape Crisis Center provides a certified rape crisis advocate to provide services as part of the response to a sexual abuse victim.

The facility has seven (7) investigators that have completed investigator training offered by North Carolina Department of Public Safety. The investigators' training is provided by the Department of Public Safety. The facility investigators also work with Greene Sheriff Department to provide any information requested by the Police Department investigators. The investigations staff interviewed indicated they meet on a regular basis to discuss investigations and involve the Police Department in informal training with facility investigators.

NCDPS Prison NCDPS Prison Policy F .3400 Inmate Sexual Abuse and Sexual Harassment mandates that facilities will immediately open a preliminary investigation when any allegation may meet the level of a PREA violation. Greene Correctional Center SOP 8.17 mandates compliance with this Policy. Greene Correctional Center assigns an Investigator immediately when information is reported or discovered. This was confirmed in review of all incidents both preliminary and incidents determined to be PREA allegations with the PREA Compliance Manager. Greene Correctional Center has a MOU with Greene Sheriff Department to conduct criminal investigations. The agency publishes the State Law, on its website, which indicates that criminal offenses will be prosecuted.

Then North Carolina Department of Public Safety (NCDPS) Prison Policy F.3400 Inmate Sexual Abuse and Sexual Harassment addresses the requirements of the standard. The facility's training addresses all of the topics identified in the standard. Related education is provided annually during refresher training. The review of lesson plans, training logs and PREA power point presentations confirmed that the provided training also addresses all elements identified in the standard.

Employees have PREA information noted on posters available to them and located throughout the facility. They are provided a PREA Brochure developed by the NCDPS PREA office and all carry a PREA reference card. Staff annual training files were reviewed and contained documentation supporting compliance with this standard. All staff interviewed indicated they received the required PREA training initially and annually. The PREA Compliance Manager and Assistant Superintendent have periodically issued memos (e-mails) to staff reminding them of and clarifying various PREA issues.

The agency maintains a Learning Management System for employees and it maintains all staff records. In order to show completion of the training, staff must first receive the training and pass a test. Staff members are required to use their personal information to enter the course and indicate they have received and meet the minimum test requirements. The extensive training provided and staff knowledge of PREA requirements confirmed that the facility is compliant with this standard. All staff members

interviewed were aware of all aspects of the training and each interviewed indicated they had received training in the previous year. All staff members that attend the Basic Training Class received the training and are then required to attend the refresher within 90 days of returning to the facility.

The Chaplain is assigned to provide the management of volunteers. Volunteers are managed in accordance with NCDPS Prison Policy F.0604, Community Volunteer Program. The volunteers, including one- time visitors, and contractors receive PREA training and undergo a yearly background check prior to being allowed into the facility or supervise inmates. NCDPS has provided a poster that is located in the

visitation room and a smaller copy is given to volunteers that provides PREA information and ways to report sexual abuse and sexual harassment.

A review of the PREA training rosters signed by contract staff, a review of the volunteer training sponsored by the Chaplain and the Chaplain's volunteer files confirmed all information required to document training. All background checks are maintained in the administrative offices and were reviewed and found up to date. All volunteer or contract staff receive copies of a PREA updates.

These updates were noted in the file and were verified through an interview with one of the facility's volunteers.

NCDPS Prison Policy F.3400 Inmate Sexual Abuse and Sexual Harassment mandates training for all inmates during their initial stay at a facility and anytime they move to another facility. Prior to being assigned to this facility each inmate goes through a diagnostic program or processing center.

During diagnostic procedures, each inmate receives training on PREA and each inmate is provided a pamphlet describing the agency's PREA program. The information identifies the key elements of the program and informs them of the zero-tolerance policy regarding sexual abuse and sexual harassment and multiple ways to report sexual abuse or sexual harassment. The information also informs the inmates they will be free from retaliation for reporting an incident and that both male and female staff members routinely work in and monitor the housing units. The information is available in English and Spanish languages.

A staff member conducts an education program regarding the PREA for all inmates upon arrival at the facility within 30 days of their arrival at the facility. The PREA education program includes definitions of sexually abusive behavior and sexual harassment, prevention strategies and reporting modalities. Inmates also view a comprehensive orientation video that explains the facilities zero-tolerance policy and covers the inmate's right to be free from sexual abuse, sexual harassment and retaliation. Telephonic translation services are available to inmates who are not proficient in English or are otherwise unable to communicate (deaf, blind, mentally impaired etc.).

Inmate interviews confirmed that they received PREA information and they were aware of numerous reporting methods to include anonymous and third-party reporting, the zero tolerance policy and their right to be free from retaliation. The tour of the Facility confirmed that several PREA education posters were prominently displayed in all housing units, the visiting rooms and common/program areas. Each time an inmate receives training it is documented in his institutional record and in the OPUS online Education Program Search Screen.

Interviews with staff and inmates; visual observations of posters/notices; examination of policy and other documentation; review of institutional files; and observation of intake procedures confirmed the facility is in compliance with this standard.

All health care persons receive specialized training through the Office of Health Services. All medical and mental health staff have received training in all requirements of the standard. All staff have received training in Sexual Abuse and Sexual Harassment as mandated for all staff. A review of the training files indicated they have all received training within the last 12 months. Additionally, all staff have received Support Services Training for persons used to continue monitoring persons who have been identified as having a history of sexual abuse or victims of sexual abuse or sexual harassment. This training identified as Course Number 0009761 - PREA: PREA SUPPORT PERSON TRAINING included roster of support staff participation in this training.

Medical and mental health staff members have received training supported by the Prison Administrative Health Services for medical and mental health staff. This training included crime scene protocol. The mental health staff members have participated in PREA specialized training and in updates for PREA training.

NCDPS Policy Prison F.3400 Inmate Sexual Abuse and Sexual Harassment addresses all components of this standard for screening new and transferring inmates. The initial screening of inmates is conducted during their intake into the Department's Diagnostic Centers. The agency has developed a Diagnostic Procedural Manual for all new intakes into the system. The Manual requires that within three days diagnostic staff will administer the Department of Prison Mental Health Screening Inventory and Screening for Risk of Victimization and Abusiveness to all newly admitted inmates. Results of the screening will be entered into the OPUS system.

All diagnostic records are confidential and only available on a need to know basis. A review of the screening instrument contains all requirements identified in the standard. The system is pass word protected for need to know staff. When transferred to another facility, the inmate receives a screening review by the Case Manager or Counselor within the first 72 hours of the inmate's arrival, but this activity ordinarily occurs within a few hours on the first day of arrival to the facility. The review of screening documents by the Auditor confirmed that inmates identified as high risk for sexual victimization or at risk of sexually abusing other inmates were referred to a mental health professional and all received further assessment (10 intake files were examined by the Auditor). Staff also reviews records or other information and information from other facilities.

The staff psychologist reviews and conducts additional screening on inmates. The facility screening instrument provides that the facility will reassess the intake screening within 30 days of the inmate arriving at the center. The inmate tracking system contains all information in computerized inmate files. Information received during the screening process is confidential and only available to staff with a need to-know and never to other inmates. Staff and inmate interviews, a review of policy/documentation (including screening documents and inmate tracking system) and observations of the intake process confirmed compliance with this standard.

NCDPS Prison Policy F.3400 Inmate Sexual Abuse and Sexual Harassment, and the Health Services Policy, TXI-13 Evaluation and Management of Disorders of Gender Dysphoria, address this standard. Risk screening information is used to determine housing, bed, work, education, and program assignments, with the goal of keeping separate those inmates at high risk of being sexually victimized from those at high risk of being sexually abusive. Determinations for these assignments are made on a case-by-case basis. Staff members assigned to conduct intake screening have been provided additional training and resource materials. The Prison Administration working with Office of Health and Mental Health Services and through a multi-disciplinary review panel decides whether to assign a transgender or intersex inmate to a facility for male or female inmates.

The facility operates a classification committee that reviews inmate's behavior, risk, and mental health status in assigning jobs and housing. Inmates may be reassigned based on any of these variables in order to maintain the inmate's safety.

The agency has no dedicated facilities for transgender or intersex inmates. The facility determines other housing and programming assignments for transgender or intersex inmates on a case-by-case basis, to include whether a placement would ensure the inmate's health and safety and whether the placement would present management or security problems. Placement and programming assignments for each transgender or intersex inmate are reassessed at least once every six months. Policy states that a transgender or intersex inmate's own views, with respect to their own safety, are given serious consideration when making these assignments. Policy also mandates that transgender and intersex inmates are given the opportunity to shower, and use toilet facilities separately from other inmates.

The facility shower areas are modified to establish privacy from staff of the opposite gender. Inmate are also allowed to dress and complete bodily functions without being in view of persons of the opposite gender.

Compliance of the standard was verified through review of policies, interviews with PREA Compliance Manager, Case Managers, facility Acting Superintendent, and psychologist, other correctional staff, inmates and tour of the facility.

NCDPS Prison Policy F.3400, Inmate Sexual Abuse and Sexual Harassment, addresses this standard as well as NCDPS Policy D.0300 Inmate Use of Mail. Sexual abuse and sexual harassment can be reported in writing, anonymously, privately, and from a third party. Staff documents all allegations. Staff members are trained to immediately report and document any sexual abuse or sexual harassment allegation. There are posters and other documents on display throughout the facility that also explain reporting methods.

The facility provides a posting explaining at least one way for inmates to report sexual abuse or sexual harassment to an entity that is not part of the agency.

NCDPS has developed a Memorandum of Understanding (MOU) with Forgiven Ministries to receive and immediately forward inmate reports of sexual abuse or sexual harassment to agency officials. The purpose of this MOU is to allow inmates to contact NCDPS through a third-party. Inmates may contact Forgiven Ministries by telephone and the contact may be made anonymously. There are phone numbers posted on all PREA posting areas and next to telephones for inmates to contact Forgiven Ministries without having to use inmate PIN or providing any other information about the reporting person. Staff members are encouraged to report anonymously through Office of Fraud, Waste, Abuse and Misconduct. Additionally, NCDPS provides staff with a brochure that provides multiple ways for staff to report allegations of sexual abuse or sexual harassment. Interviews with staff and inmates; observations of posters addressing reporting methods; and an examination of policies, documentation, and the MOU confirm compliance with this standard.

NCDPS Prison Policy E.0300 Administrative Remedy provides all areas indicated in the PREA standard for exhausting of administrative remedies. The policy also provides for Inmates to transfer grievances. Inmates are not required to use an informal grievance process or otherwise attempt to resolve an alleged incident of sexual abuse with staff. There are no time limits when sexual abuse allegations can be made. Inmates are able to submit grievances without giving the document to the staff person involved.

Does Not Meet Standard (Requires Corrective Action)

The standard requires a decision to be made on the merits of any grievance alleging sexual abuse within 90 days. NCDPS Prison Policy requires a response time of 30 days. Policy and procedures permits third parties to assist inmates in filing request for administrative remedies relating to allegations of sexual abuse and are also permitted to file such requests on behalf of an inmate. Policy and procedures are in place that allow for an inmate to file an emergency grievance alleging there is substantial risk of imminent sexual abuse. Any grievance received by staff alleging an inmate is subject to a substantial risk of imminent sexual abuse will be reported to the OIC (Officer in Charge) at which point immediate corrective action may be taken. The initial response is completed before the end of the shift of when the incident was reported and the final agency decision within five days. There was one (1) grievances alleging sexual abuse or sexual harassment filed within the last 12 months. Review of the grievance and investigation found that grievance response within 7 days. Investigator and a retaliation PREA support person were assigned at the same day grievance was received and investigation began within same day. Inmate did not ask for movement or job change. Inmate agreed to findings of the grievance officer and did not request an appeal.

Interviews with staff (including the Grievance Coordinator) and inmates and an examination of supporting policy/documentation confirm compliance with this standard.

NCDPS Prison Policy F.3400 Inmate Sexual Abuse and Sexual Harassment states that upon receiving an allegation that an inmate was sexually abused while confined at another facility, the Superintendent will notify the head of the facility or appropriate office of the agency or facility where the sexual abuse allegedly occurred. Policy requires such notification will occur as soon as possible and no later than 72 hours of receiving the allegation. Documentation is required of any such notification.

There has been 2 allegation of an inmate being sexually abused while confined at another facility during the previous 12 months. The facility immediately began an investigation and forwarded the investigation to the sending facility. The Superintendent notified the sending Superintendent by phone and forwarded email to Regional Director and sending facility within five hours of being advised.

There was one allegation of an inmate being sexually abused at Greene Correctional Center that was received at another institution during intake screening at receiving institution. Greene Correctional Institution was notified by the receiving facility and immediately began an investigation. The receiving institution completed an initial investigation and forwarded a copy of this investigation to the Greene Correctional Center. The receiving and Greene Correctional Center cooperated in completing investigation and notifying the inmate of the outcome of the investigation. The receiving facility also provided mental health referral to inmate.

Compliance with this standard was verified by reviewing Policy, email chains, initial investigative report, completed investigative report and interviews with staff from receiving institution, investigators and Greene Correctional Center PREA compliance manager.

The facility operates under the Prison Administration Inmate Sexual Abuse and Sexual Harassment Policy. The Policy outlines duties, procedures and actions for first responders to an allegation of sexual abuse. The PREA training lesson plan outlines the duties and responsibilities for first responders and medical staff in the event an inmate is sexually abused. Inmates may report acts of sexual assault, abuse, or harassment to any employee, contract employee, or volunteer.

Upon learning of an allegation that an inmate was sexually abused, if the responder is a correctional officer: 1) separate alleged victims and alleged abuser; 2) preserve and protect the crime scene; 3) if the time allows for the collection of physical evidence, make appropriate request for it; 4) if the abuse occurred within a time period that allows for physical evidence, ensure the alleged abuser does not destroy evidence.

First responders interviewed were knowledgeable about their duties and responsibilities. All staff were carrying an embossed card as reference to direct them as to their responsibilities as a first responder to an allegation of a PREA incident.

During the last 12 months there have been three (3) allegations of sexual abuse reported to correctional staff. Only one (1) report was made within a time frame for the staff to respond as first responders. In this case staff completed all requirements of this standard.

Compliance was verified through review of policy, training plan, interviews with correctional (including first responder) and non-correctional staff.

This plan addresses first responder duties, leadership duties, investigator duties, PREA compliance manager duties, PREA Support Persons duties, Mental Health and aftercare duties, and retaliation duties.

Greene Correctional Center has developed SOP 8.17 Coordinated Response Plan and trained staff on coordinated response plan. The response plan describes the duties of the first responder, medical and mental health staff, investigators, and facility leadership PREA manager and Support Persons duties in coordinating actions taken in response to an incident of sexual abuse. The facility has a Sexual Abuse Response and Investigation Checklist for allegations that include contacting the agency

PREA Director and local law enforcement; as well as the collection of any possible evidence. Interviews with staff and a review of the policy; coordinated response plan; investigative logs, and other documentation confirm that the facility is in compliance with this standard.

Facility Prison Policy F.3400 Inmate Sexual Abuse and Sexual Harassment, addresses the requirements of this standard.

The policy specifically prohibits any type of retaliation to any inmate or staff member who has reported sexual abuse, sexual harassment or has cooperated with such investigations. The facility has designated PREA Support Persons (PSP) as the designated staff members that monitor the conduct or treatment of inmates who have reported sexual abuse to ensure any type of retaliation does not occur.

When interviewed, several of the PSPs stated they would document and follow up on all potential cases to ensure that the policy is being enforced. Additionally, the PSPs stated that they would conduct periodic status checks on the frequency of incident reports, housing reassignments, program changes, any negative consequences for reporting abuse, and negative performance reviews/staff job reassignments (all steps required of 115.67c).

If there was a concern that there was the potential for possible retaliation, the PSP stated they would monitor the situation longer if approved by the superintendent. The monitoring of any type of retaliation will be done for at least 90 days or as long as needed to make sure the inmate is safe from retaliation or the inmate is transferred.

The policy outlines the protection measures available and requires the prompt remediation of any type of retaliation. NCDPS has developed a designated form to be used when retaliation is being monitored. This document maintains all the requirements established in the standard for agency protection against retaliation. A review of the retaliation found that all inmates making allegations were assigned a PSP. In one case, a resident's allegation was found unsubstantiated and retaliation monitoring did not continue past sixty (60) days as required.

The center retrained PREA Support Staff to ensure that they knew that retaliation monitoring continues unless inmate's allegation is unfounded.

Substantial compliance with this standard was determined by a review of policy/documentation and staff interviews. A review of the PSP files and interview with the inmate and PSP confirmed substantiated compliance with this standard. A corrective action plan was completed to retrain staff on monitoring unless inmate's allegation is unfounded.

The agency policy requires that criminal investigations are conducted by outside law enforcement, therefore the facility investigators only conduct an initial investigation to determine if outside law enforcement is to be notified for criminal allegations. The Facility or other Prison agency investigators conduct administrative investigations. When the facility conducts investigations, the agency uses investigators who have received specialized training in conducting sexual abuse investigations in a confinement setting.

Administrative investigations address staff actions, credibility and a review of fact and findings of the criminal investigation (if applicable). All interviews are conducted as approved by the Office of Special Investigations and Compliance. Both criminal and administrative investigations are well documented and maintained in the files. Files reviewed included a copy of the law enforcement report, if they conducted a criminal investigation, statements of victim, alleged abuser (if identified) and witnesses, and statements by the PSP and Investigator as to the steps they took during their investigation.

Investigators gather and preserve direct and circumstantial evidence, including any available physical and DNA evidence and any available electronic monitoring data. Investigators interview alleged victims, suspected perpetrators, and any other possible witnesses. Investigators review prior reports and complaints of sexual abuse involving the suspected perpetrator. The agency only conducts compelled interviews after consulting with prosecutors as to whether compelled interviews may be an obstacle for subsequent criminal prosecution.

Substantiated allegations of conduct that appear to be criminal are referred for prosecution. The credibility of an alleged victim, suspect or witness is assessed on an individual basis and is not determined by the person's status as inmate or staff. The agency does not require an inmate who alleges sexual abuse to submit to a polygraph examination or other truth assessment device as a condition for proceeding with the investigation of such an allegation.

All administrative investigations include an effort to determine whether staff actions or failures to act contributed to the abuse. Administrative investigations are documented in written reports that include a description of the physical evidence and testimonial evidence, the reasoning behind credibility

assessments, and investigative facts and findings. Criminal investigations are documented in a written report that contains a thorough description of the physical, testimonial, and documentary evidence. The agency retains all written reports pertaining to the administrative or criminal investigation of alleged sexual assault or sexual harassment for as long as the alleged abuser is incarcerated or employed by the agency, plus five years.

The agency does ensure that the departure of an alleged abuser or victim from the employment or control of the agency does not provide a basis for terminating an investigation. When an outside entity investigates sexual abuse, the facility cooperates with outside investigators and endeavors to remain informed about the progress of the investigation. Utilizing the working paper documents for conducting reviews of investigative files, three case files of inmates alleging sexual abuse/harassment were reviewed. The findings were that cases were managed appropriately, completed promptly, thoroughly and in compliance with Policy.

The PREA Support Person is responsible for the implementation of this Policy. NCDPS developed Form OPA-130A for providing information to inmates during and at the conclusion of investigations for sexual abuse or sexual harassment.

Support services staff in line with policy F .3400, following an investigation into an inmate's allegation of sexual abuse in an agency facility, the agency informs the inmate as to whether the allegation has been determined to be substantiated, unsubstantiated, or unfounded. If the agency did not conduct the investigation into an inmate's allegation of sexual abuse, the agency will request the relevant information from the investigative agency to inform the inmate.

Following an inmate's allegation that a staff member has committed sexual abuse against him, unless the agency has determined that the allegation is unfounded (or unless the inmate has been released from custody), the agency subsequently informs the inmate whenever the staff member is no longer posted within the inmate's unit or the agency learns that the staff member has been indicted and convicted on a charge related to sexual abuse in the facility.

Following an inmate's allegation that a staff member has committed sexual abuse (unless the agency has determined that the allegation is unfounded or unless the inmate has been released from custody), the agency subsequently informs the inmate whenever the agency learns that the staff member has been convicted on a charge related to sexual abuse within the facility.

Following an inmate's allegation of sexual abuse by another inmate, the agency will subsequently inform the alleged victim whenever the agency learns that the alleged abuser has been indicted or convicted on a charge related to sexual abuse within the facility.

The agency documents all such notifications or attempted notifications using NCDPS form OPA-130A.

Compliance with this standard was verified through the review of policy, completed forms and interviews with PREA Support Staff and PREA compliance manager.

Inmate Disciplinary Procedures and the Inmate Hand Book address the standard for compliance with PREA Disciplinary Sanctions for Inmates. Information on inmate disciplinary sanctions is provided as part of the orientation process upon entry into the facility.

Policy states inmates are subject to disciplinary sanctions following an administrative finding the inmate engaged in inmate-on-inmate sexual abuse or following a criminal finding of guilt for inmate-on-inmate sexual abuse. The facility prohibits all sexual activity between inmates. Sanctions are commensurate with the nature and circumstances, subject's prior history, and sanctions imposed for comparable offenses. The inmate's mental health is also considered.

Inmates may be disciplined for sexual contact with staff only upon a finding that the staff member did not consent to such contact. The facility does not discipline inmates who make an allegation in good faith, even if an investigation does not establish evidence sufficient to substantiate the allegation.

Staff ensures that the inmate is offered a follow-up meeting with a medical or mental health practitioner within 14 days of the intake screening where abuse was alleged.

Any information related to sexual victimization or abusiveness that occurred in an institutional setting is limited to medical and mental health practitioners and other staff, as necessary, to inform treatment plans and security and management decisions, including housing, bed, work, education, and program assignments, or as otherwise required by Federal, State, or local law. Medical and mental health practitioners obtain informed consent from inmates before reporting information about prior sexual victimization that did not occur in an institutional setting, unless the inmate is under the age of 18. Secondary mental health/medical materials and consent documentation can be found in the medical area of the facility.

Policy and protocol mandates inmate victims of sexual abuse receive timely, unimpeded access to emergency medical treatment and crisis intervention services, the nature and scope of which are determined by medical and mental health practitioners according to their professional

judgment. The facility has medical staff on duty 24 hours per day seven days a week.

The security staff first responders will immediately notify the appropriate medical and mental health practitioners. Where medically appropriate the facility will ensure victims are offered timely information about and timely access to emergency contraception and sexually transmitted infections prophylaxis, in accordance with professionally accepted standards of care. All treatment services will be provided to the victim without financial cost and regardless of whether the victim names the abuser or cooperates with any investigation arising out of the incident.

Greene Correctional Center has a MOU for mutual aid and uses the Vidant Hospital that provides a Sexual Assault Nurse Examiner for conducting the medical forensic examination and provides medical care as required. The MOU with the Rape Crisis Center (RCC) provides staff to report to the hospital as required to provide support services. Verification was confirmed by review of Policy, interviews with medical and mental health staff, and telephone conversations with the representative from the Rape Crisis Center.

The facility has a local SOP .4600 that also mandates and establishes members of the incident review team. The review is conducted within 30 days of the conclusion of the sexual abuse investigation.

The incident review team includes upper-level management officials, with input from line supervisors, investigators, and medical and/or mental health practitioners. The review team considers whether the allegation or investigation indicates a need to change policy or practice to better prevent, detect, or respond to sexual abuse in each review. The review team also considers whether the incident or allegation was motivated by race; ethnicity; gender identity; gay, bisexual, transgender, or intersex identification, status, or perceived status; gang affiliation; or other group dynamics at the facility.

The area in the facility where an incident allegedly occurred is assessed by the incident review team as

to whether physical barriers in the area may enable abuse. Additionally, the review team assesses the adequacy of staffing levels in the area of the facility where a sexual abuse incident allegedly occurred, during different shifts. The review team also assesses whether monitoring technology should be deployed or augmented to supplement supervision by staff on each incident. A written report of the incident review team's findings, including any recommendations for improvement is developed and submitted to the Acting Superintendent.

The incident review team provided documentation of incident reviews, completed investigative information, findings of Incident Reports, and documentation supporting implementations or reasons for not implementing recommendations.

NCDPS Prison Policy F .3400 Inmate Sexual Abuse and Sexual Harassment provide guidelines for compliance with this standard. The PREA Office reviews data collected and aggregated in order to assess and improve the effectiveness of sexual abuse prevention, detection, policies, practices, and training. The review of data encompasses identifying problem areas and taking corrective action on an ongoing basis. The agency has an annual report, including corrective actions for the facilities.
